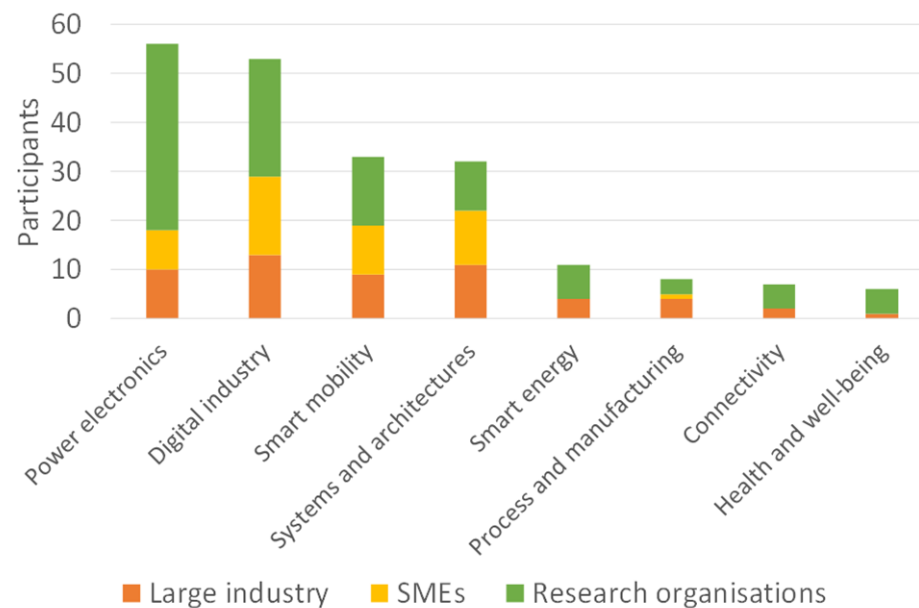


ECSEL and Italy (2014-2018)

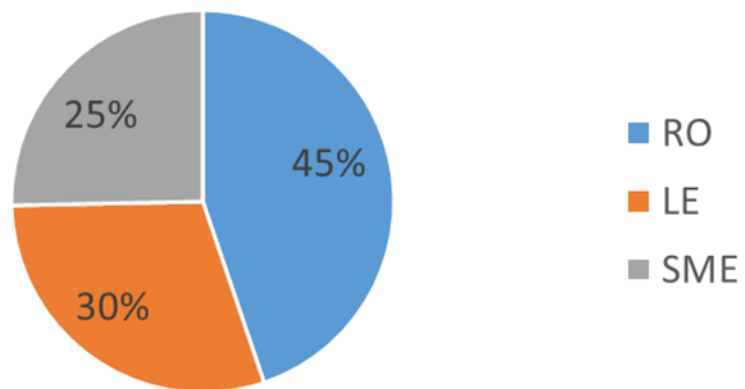


In the period 2014-2018:

- 40 projects with Italian partners.
- 87 Italian beneficiaries in 40 projects



Italian partners ECSEL 2014-2018



Italian partners by organization:

- 45% from Research Organizations
- 30% from Large Enterprises
- 25% from SME

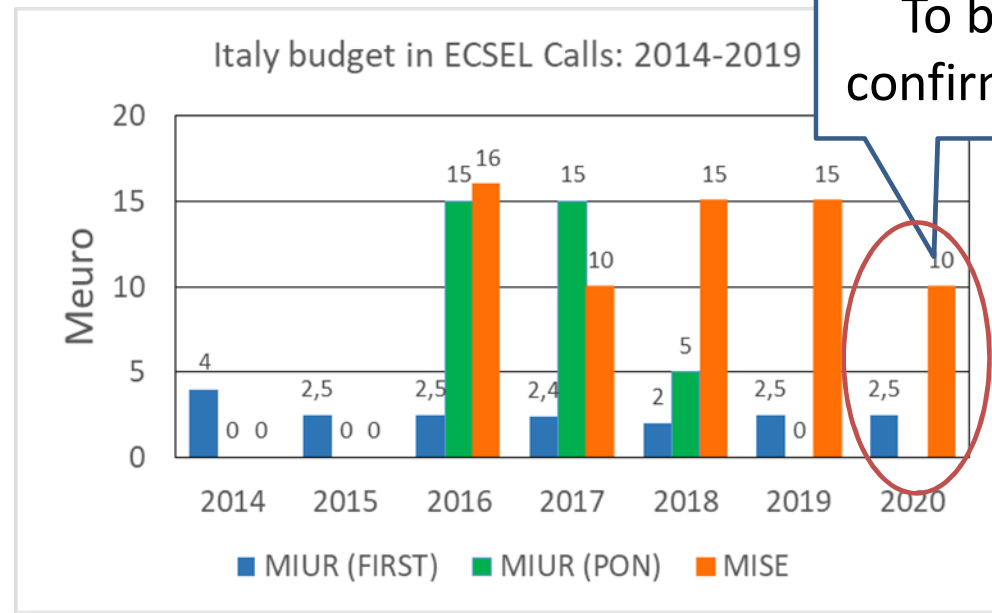
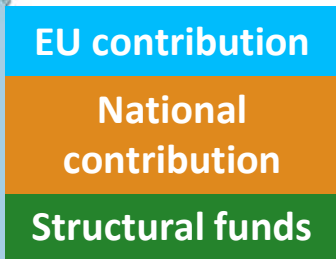
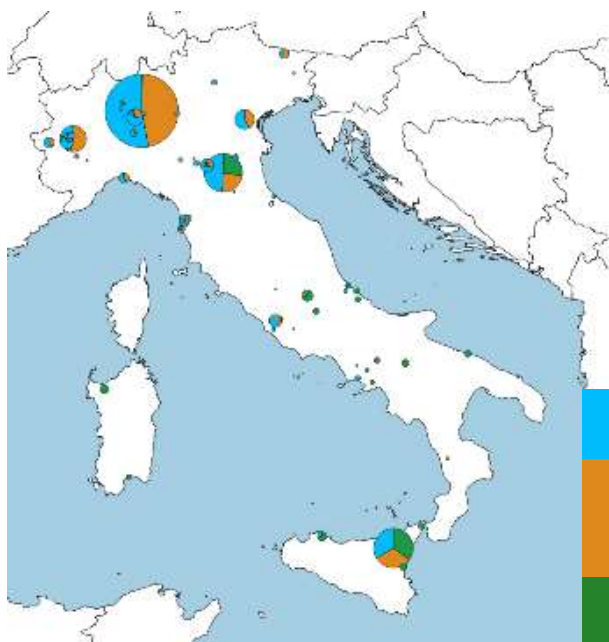


Funding allocation (2014-2019)



In the period 2014-2019:

- 15,9 M€ made available by MIUR, 56M€ by MISE and 35M€ from structural funds.
- 91M€ of ECSEL JU funding (2014-2018)



- Structural funds are limited to Southern Italy
- No structural funds after 2018 call, because they cannot be used beyond 2020



Why ECSEL Italy?

The ECSEL Italy Mirror Group is linked to the ECSEL Mirror Groups Austria and Digital Sweden.

It is formed by volunteers from Italian industrial and academic institutions involved in ECSEL:

- To facilitate / coordinate the participation of Italian partners to the calls of ECSEL (and H2020).
- To promote the public support to ECSEL in Italy
- To coordinate with similar European initiatives and especially PPP's.

ECSEL Italy Days



- The National day of ECSEL Mirror Group Italy are held yearly before ECSEL calls
- They are the reference forum for Italian participants to the ECSEL calls and other H2020 funding programs.
- Traditionally divided into two parts, with networking spaces:
 - Institutional presentations by ECSEL Office, funding Ministries and other agencies;
