




Why ECSEL?



ECSEL is the largest European funding program for Microelectronics, Electronics and Smart Systems



With respect to H2020:

- · Application oriented.
- Much space for Smart Systems, strong point of Italian SME's.
- · Covers prototypes and pilot lines.
- Large projects in size and number of participants.
- Combines European, national and regional funds.
- Success rate around 30%.

In the period 2014-2018:

- 13,4 M€ made available by MIUR, 41€ by MISE and 35€ from structural funds.
- 81M€ of ECSL JU funding (2014-2017)
